Visitor Policy

PURPOSE

To provide a safe and secure learning and teaching environment for students and staff by establishing processes to monitor and manage visitors to MEC.

SCOPE

This policy outlines our school's arrangements for visitors who attend school grounds when the school is open for instruction between the hours of 8:30am to 3:15pm, outside of these hours the general office is staffed until 4.30pm to receive visitors, including parents/carers and contractors. Outside of these times, our front office is not staffed, and this policy does not apply.

DEFINITIONS

Child-related work: As defined by the *Worker Screening Act 2020* (Vic), child-related work is work that usually involves direct contact (including in person, over the phone, written and online communication) with a child that is a central part of that person's duties. It does not include work that involves occasional direct contact with children that is incidental to the work.

POLICY

MEC strives to create an open and inclusive school community and encourages parents and carers to be actively involved in their child's development and education. We also strive to foster strong partnerships with local community services, schools and other organisations.

MEC is not a public place. The principal has the authority to permit or deny entry to school grounds and encourages all visitors to familiarise themselves with our school's <u>Statement of</u> <u>Values and School Philosophy</u>, <u>Child Safety Policy</u>, <u>Child Safety Code of Conduct</u>, <u>Volunteers</u> <u>in Schools Policy</u>.

From time to time, different members of the public may visit our school. Visitors may include, but are not limited to:

- Parents.
- Volunteers see our school's Volunteers Policy for more information.
- Prospective parents, students and employees.
- Invited speakers, sessional instructors and others addressing learning and development.
- Public officials (e.g. Members of Parliament, local councillors).
- Persons conducting business e.g.: uniform suppliers, booksellers, official school photographers, commercial salespeople.
- Tradespeople.
- Children's services agencies.
- Department of Families, Fairness and Housing workers.

- Victoria Police.
- Persons authorised to enter school premises (e.g. WorkSafe inspectors, health officers etc).
- Other Department of Education staff (including allied health staff) or contractors.
- NDIS therapists or other allied health or health practitioners.

Sign in procedure

All visitors to MEC are required to report to the school office on arrival (see exceptions below in relation to parents/carers).

Visitors must:

- Record their name, signature, date and time of visit and purpose of visit on sheet provided or by using our computer system in the general office.
- Provide proof of identification to office staff upon request.
- Produce evidence of their valid Working with Children Clearance where required by this policy (see below).
- Wear a visitor's lanyard at all times.
- Follow instruction from school staff and abide by all relevant school policies relating to appropriate conduct on school grounds including Child Safety Code of Conduct, Respect for School Staff, Statement of Values and School Philosophy as well as Department policies such as the <u>Sexual Harassment Policy</u> and <u>Workplace Bullying</u> <u>Policy</u>.
- Return to the office upon departure, sign out and return visitor's lanyard.

MEC will ensure that our school's Child Safety Code of Conduct is available and visible to visitors when they sign in.

Working with Children Clearance and other suitability checks

For Working with Children (WWC) Clearance and other suitability check requirements relating to parents/carers and other volunteers working with students please see our Volunteers Policy.

All visitors who are engaged in **child-related work** (see definition above) must have a valid WWC Clearance.

In some circumstances, visitors to MEC who are **not** engaged in child-related work will also be required to produce a valid WWC Clearance depending on the particular circumstances of their visit. For example, MEC will require a valid WWC Clearance for:

- Visitors who will be working regularly with children during the time they are visiting, even though direct contact with children is not a central part of their normal duties.
- Visitors (e.g. contractors), who will regularly be performing unsupervised work at the school during school hours or any other time where children are present. Further background checks, including references, may also be requested at the discretion of the principal.

Visitors who will be working in areas away from students (e.g. a visiting auditor who will be located in the front office with administration staff) or who will be supervised and accompanied by a staff member during their visit (e.g. a Member of Parliament, a journalist, a prospective parent on a school tour) will not be required to have a WWC Clearance.

Sworn Victoria Police officers or sworn Australian Federal Police officers are exempt from requiring a WWC Clearance but may be asked to verify that they are sworn officers by providing proof of identification.

Invited speakers and presenters

On occasion, MEC may invite external speakers or providers to deliver incursions, presentations, workshops and special programs for our students. Consistent with Department of Education requirements, MEC will:

- Ensure that the content of presentations and programs by external providers contributes to the educational development of our students and is consistent with curriculum objectives.
- Ensure that any proposed visit, programs, or content delivered by visitors complies with the requirement that education in Victorian government schools is secular and is consistent with the values of public education, Department policies and the *Education* and *Training Reform Act 2006* (Vic). In particular, programs delivered by visitors are to be delivered in a manner that supports and promotes the principles and practice of Australian democracy including a commitment to:
 - Elected government.
 - The rule of law.
 - Equal rights for all before the law.
 - Freedom of religion, speech, and association.
 - The values of openness and tolerance.
 - Respect for the range of views held by students and their families.

Parent visitors

We understand that there may occasionally be a reason why a parent or carer may want to speak to or see their child at school, during school hours.

If there is a particular pressing or unavoidable issue that cannot wait until the end of the school day, we ask that parents or carers call the school office to make the request to speak to or see their child during school hours.

We also ask that parents avoid arranging to visit their children at school wherever possible, as this can cause inappropriate disruptions to the school day.

All parents or carers who visit our school during school hours, other than for the purposes of school pick ups and drop offs or for specific school events (e.g. parent teacher interviews, concerts, assemblies etc), are required to sign in as a visitor at the school office.

Parents or carers who are prohibited from entering the school under a court order or direction of the principal are not permitted to visit the school. Our school maintains and provides office staff with a list of restricted parents/carers which may include identifying photographs and any other information as required depending on the level of risk posed.

Other visitors

All business operators, tradespeople and other visitors attending the school to conduct work must report to the school office upon arrival for instruction and follow the sign in procedure outlined above.

COMMUNICATION

This policy will be communicated to our school community in the following ways:

- Available publicly on our school's website.
- Included in induction processes for staff.
- Discussed in an annual staff briefing/meeting.
- Made available in hard copy from school administration upon request.
